to comply with the obligations referred to in EU Regulation 2016/679, we invite you to take note of the information pursuant to art. 13 of EU Regulation 2016/679 and to express consent to the processing of data, by signing and returning the attached form.

#### **1. Purpose of the processing for which the data is intended**

The processing of the personal data provided is aimed solely at:

- a) Execution of contracts entered into with you and related commitments;

### **7. Identification details of the data controller and of the data processing manager**

### **8. Rights pursuant to art. 15, 16, 17 18, 20, 21 and 22 of EU Regulation 2016/679**

We inform you that in your capacity as an interested party, you have, in addition to the right to lodge a complaint with a supervisory authority, the rights listed below, which you can assert by making a specific request to the data controller and / or the data processor, as indicated in point 6.

#### Art. 15-Right of access

The interested party has the right to obtain confirmation from the data controller as to whether or not their personal data is being processed and, if so, to obtain access to personal data and information regarding the processing.

#### Art. 16 - Right to rectification

The interested party has the right to obtain from the data controller the correction of inaccurate personal data concerning them without undue delay. Taking into account the purposes of the processing, the interested party has the right to obtain the integration of incomplete personal data, also by providing an additional declaration.

#### Art. 17 - Right to erasure (right to be forgotten)

The interested party has the right to obtain from the data controller the deletion of personal data concerning him without undue delay and the data controller has the obligation to delete personal data without undue delay.

#### Art. 18 - Right to restriction of processing

The interested party has the right to obtain from the data controller the limitation of the processing when one of the following situations occurs:

- a) the data subject disputes the accuracy of the personal data, for the period necessary for the data controller to verify the accuracy of such personal data;
- b) the processing is unlawful and the interested party opposes the deletion of personal data and requests instead that its use be limited;

Art. 20 - Right to data portability

The interested party has the right to receive in a structured format, commonly used and readable by an automatic device, the personal data concerning them provided to a data controller and has the right to transmit such data to another data controller without impediments on the part of the data controller to whom it was provided. In exercising their rights regarding data portability pursuant to paragraph 1, the interested party has the right to obtain the direct transmission of personal data from one data controller to another, if technically feasible.

Art. 21 - Right to object

The interested party has the right to object at any time, for reasons connected to their particular situation, to the processing of personal data concerning them pursuant to article 6, paragraph 1, letters e) or f), including profiling on the basis of these provisions.

Art. 22 - Right to not be subjected to automated decision-making, including profiling

The interested party has the right not to be subjected to a decision based solely on automated processing, including profiling, which produces legal effects concerning them or which significantly affects them in a similar way.
